Non-Exclusive License Agreement

In Consideration of the display and promotion of works created and other consideration, the sufficiency and receipt of which are acknowledged, I _____, the sole owner of copyrights in the work or works of art created by me, and identified in Attachment A ("the Work") which are accessioned into the collection or are on loan to Brandi Fenton Memorial Park at Binghampton, Pima County Natural Resources, Parks and Recreation ("PC NRPR"), hereby grant to Pima County, Arizona, a political subdivision of the state of Arizona (the "County"), a non-exclusive worldwide license at no cost for:

- NRPR to publicly display the Work in NRPR's facilities for educational and Exhibition purposes. This agreement also includes the right of NRPR to copy, photography or otherwise reproduce the Work for all standard park purposes, including, but not limited to, registration, documentation, record-keeping, archiving, lecture slides, publications in exhibition catalogues, books, brochures, or the like, exhibition publicity in all media now known or hereafter created, including in books, magazines, newspapers, television, films, videos, prints, posters, electronic media, computer-based applications, web pages, web sites, internet links and on the World Wide Web, and any other purposes deemed necessary by NRPR in connection with the exhibition or general NRPR publicity;
- NRPR to copy, photograph, or otherwise reproduce the Work or Works of Art created by me for non-commercial and educational purposes and to permit third parties to do so; and

NRPR may use, at its sole discretion, or permit third parties to use, my name, photograph, likeness and biographical information in connection with the exercise of all rights granted herein. This constitutes a waiver of my right of publicity and related privacy rights and is binding on my heirs, assigns and other transferees.
